What are you being asked to do?

You are invited to participate in the project by participating in a 20-30 minute interview. The data you provide will help to ensure the developed resources include the information and support that schools, P&C/P&F committees and parents would prefer and find helpful.

Why is this project important?

Children today grow up in a world immersed in digital technology. Although access to digital technology can have enormous educational and social benefits, use by children is not without risk, especially as children are still developing socially and emotionally, and in their ability to make sound decisions. Despite growing research on children's use of technology and the Internet, and the consequences of this increased engagement, little research has been conducted with parents to determine their needs or effective ways of enabling parents to guide their children's digital behaviour. Similarly, many school staff also lack the confidence and skills to teach and foster safe and positive digital technology use by their students, and many primary schools are not adequately supported in this regard.

Who is doing this study?

The study is being conducted by the Telethon Kids Institute in collaboration with the Office of the eSafety Commissioner (OESC), the WA Council of State Schools Organisations (WACSSO) and the Parents and Friends Federation of WA (PFFWA). The research team comprises Prof Donna Cross and Dr Kevin Runions from the Telethon Kids Institute; Associate Prof Matt Byrne, Edith Cowan University; and Dr Shirley Knight, Curtin University.

What are the possible benefits of this project?

Should the resources developed in this project be found to be helpful, they will be made available to all Western Australian primary schools and their parents.

What are your choices?

Your participation in this project is entirely voluntary. You can withdraw from the project at any time, without reason and without prejudice, and with no consequences associated with your withdrawal.

Is the information I give private and confidential?

All the information we collect from you will remain strictly confidential. Your name will not be linked to what you say and will not be included in any reports written from this project. It is important to state that at no time will anyone external to the project be able to identify what you have personally said unless this is a legal requirement.

With your permission the interview will be recorded to make sure we have an accurate recording of what was said. We will ask that participants not refer to anyone else by name during the discussions. All information will be stored securely (in locked cabinets and electronically in password protected files) at the Telethon Kids Institute for at least seven years before being destroyed.

We plan to present findings from this study at various health and education conferences, and to publish results from the data in scientific journals. Your data will remain confidential and no one's name and no school name will be included in any of the reports or papers, or in the presentations produced as a result of this research.

What are the possible risks of being involved in this project?

We do not anticipate any significant risk to you by participating in this study.
